## AUTHORIZATION TO USE TITLE IV FUNDS

Federal Title IV aid programs include Pell, SEOG, and Direct Loans. According to federal regulations, Ithaca College must use these funds to pay for your tuition, mandatory fees, and room and board charges. Title IV recipients have the options of allowing the College to apply excess Title IV funds toward other expenses on their billing accounts, to carry forward any excess from one semester to a subsequent semester within an award year (July 1 – June 30 of the following year), and/or to pay any minor outstanding charges (medical charges, traffic or library fines, departmental charges) from a prior year. This form allows you to indicate to us whether you do or do not want to allow the College to apply your excess Title IV funds to these options.

This form will remain in effect as long as you are a student at Ithaca College; if you are an entering student, please remember this when making your selection in the "prior year" section. Options may be rescinded at any time by contacting the Office of Student Financial Services (note that changes are not retroactive).

I authorize Ithaca College to apply my Federal Title IV funds as indicated below; remember that these options pertain to your entire period of study (**please pick one option from each category**):
