SUMMER SESSION 2021 FINANCIAL AID INFORMATION

SPECIAL NOTE TO RISING PHYSICAL THERAPY (PT) AND OCCUPATIONAL THERAPY (OT) SENIORS AND TO PT GRADUATE STUDENTS: PT or OT majors who will be starting as a senior in 2021 or students who will be a PT graduate student for the summer session are exempt from filing this form. You are required to file all other aid applications necessary to receive financial aid, including the 2021-2022 FAFSA, and, if an undergraduate who is a New York state resident, a TAP application.

SUMMER AID ELIGIBILITY

Financial aid for summer 2021 sessions may include Federal Direct/PLUS loans, Federal Pell Grant, NYS Tuition Assistance Program (TAP), and the Ithaca College Grant. The following funds CANNOT be used during summer sessions: NMF Recognition Award, Ithaca College Scholarships, Ithaca Heritage Grant, Ithaca Sibling Grant, MLK Scholarship, Ithaca Leadership Scholarship, Park Scholarship.

Using Pell Grant, TAP, or Direct Loan during summer session may reduce funding available from these sources during the following fall and spring semesters. Aggregate limits also may be impacted in the future. The College cannot replace these funds should this occur.

Generally speaking, you must be enrolled for at least six credits (undergraduates) or five credits (graduates) in order to be considered for financial aid, although some forms of aid for undergraduates require fewer credits. **Graduate students taking fewer than five credits are not eligible for summer aid.**

It is your responsibility, if awarded financial aid, to provide the forms required in order to receive the aid you have been awarded. **If you register for less than the number of credits you estimate on this form, we reserve the right to reduce or eliminate any aid offered. It is your responsibility to notify us in writing of any decrease in the number of credits you plan to take prior to summer school registration.**

THE PROCESS

- Complete the reverse side of this page and return it to the Office of Student Financial Services by April 1, 2021. Applications received after this date will be reviewed AFTER those that were filed by the deadline.
- File your 2021-2022 FAFSA by March 1, 2021 (preferably) or before April 1, 2021. After you file your FAFSA, you will receive a Student Aid Report (SAR). Make sure that Ithaca College is listed on your SAR. *Note: International students are exempt from completing the FAFSA.*
- We will respond to most requests for summer aid by email (new graduate students will be contacted by regular mail) by May 15, 2021. Based on our review, one of two things will happen: you either will be given a financial aid notification that you may use to defer against your summer charges, or you will be advised that no aid is available.

Because you may pre-register for courses without making payment, it is strongly recommended that you do not register for courses until receiving an official financial aid award notification from the Office of Student Financial Services, or you may risk owing the College more than you anticipated.
